Tárgy: Javaslat az URBACT II RegGov  
zárókonferencián való részvételre

**Tisztelt Képviselő-testület!**

A Kőbányai Önkormányzat részt vesz a 2008. óta tartó URBACT RegGov európai uniós együttműködési programban. Az URBACT II. programban való részvételéről a Képviselő-testület 313/2008. (II. 28.) sz. határozatával döntött. A programban való részvételhez szükséges intézkedésekről és az önkormányzat delegációjának részvételéhez szükséges forrás biztosításáról a 929/2008. (V. 22.) sz. határozatával döntött.

A program zárókonferenciája 2011. májusában, a németországi Duisburg-ban kerül megrendezésre, a mellékeltetett program szerint. A konferencia hivatalos programja május 12-13-án lesz, az első nap kimondottan az URBACT RegGov program záróeseménye. A konferencia részeként sor kerül az URBACT RegGov program tapasztalatainak felhasználásával készült helyi akcióterületi tervezetek (Local Action Plan), köztük a Kis-Pongrác lakótelep szociális városrehabilitációja akcióterületi tervének bemutatására is. A második napon kerül megrendezésre az Észak-Rajna-Westfália régió és az URBACT RegGov partnervárosok közös projektbemutató kiállítása és kerekasztal beszélgetései. Ezen az eseményen egy külön standja lesz az URBACT RegGov partnervárosoknak, és lehetőség lesz rá, hogy kiállítási tablókon bemutassuk a Kis-Pongrác lakótelep akcióterületi tervén alapuló EU projekt terveit és további információkat Kőbányáról.

A szervezők kérése, hogy az eseményen az URBACT RegGov munkájában eddig résztvevő szakembereken felül a kerület döntéshozói, az akcióterületi terv alapján kidolgozott tervezet készítői, valamint a program EU támogatásáért felelős irányító hatóság (Nemzeti Fejlesztési Ügynökség) szakemberei is képviseltessék magukat. Fentiek alapján a Kőbányai Önkormányzat részéről Radványi Gábor alpolgármester vezetésével és Marksteinné Molnár Julianna bizottsági elnök részvételével nyolc fős delegáció kiküldetése javasolt.

Az utazási és szállásköltség fedezete a 2011. évi költségvetés 56212 főkönyvi számon, „957 URBACT II” program létesítménykódon rendelkezésre áll. A konferencián résztvevők utazási és szállásköltségei (beleértve a nem a Kőbányai Önkormányzatnál dolgozókét is) az URBACT program keretén belül elszámolhatóak, azokat az Önkormányzat utólag visszaigényelheti.

Kérem a tisztelt Képviselő-testületet az előterjesztés megtárgyalására és a határozati javaslat elfogadására.



# European Conference of the URBACT II RegGov Network

## The URBACT II Programme

URBACT is a European exchange and learning programme promoting sustainable urban development. It enables cities to work together to develop solutions to major urban challenges, reaffirming the key role they play in facing increasingly complex societal changes. URBACT helps cities to develop pragmatic solutions that are new and sustainable, and that integrate economic, social and environmental dimensions. It enables cities to share good practices and lessons learned with all professionals involved in urban policy throughout Europe. URBACT is 300 cities, 29 countries, and 5,000 active participants. URBACT is part-financed by the European Union (European Regional Development Fund).

## The RegGov Project

In close cooperation with the Ministry for Economic Affairs, Energy, Building, Housing and Transport of the State of North Rhine-Westphalia and with the special support of the Directorate General for Regional Policy, the City of Duisburg / EG DU Entwicklungsgesellschaft Duisburg mbH is leading the European RegGov Network (URBACT II) which targets the regeneration of deprived neighbourhoods. A key aim is close horizontal and vertical cooperation from neighbourhood level to the managing authorities, which is pivotal in the success of long-term and sustainable urban neighbourhood renewal.

In the framework of the conference on 12 May 2011, the experience and results generated in three years of network activities will be presented to a broad audience and discussed. The Local Action Plans which have been developed will be released. Apart from the mayors and involved parties from the partner cities and their managing authorities, high-ranking representatives from the European Commission and the URBACT programme will participate.

In the framework of the international exhibition on 13 May 2011, the RegGov Network will present itself with its partners and actively take part in the debate, together with the Directorate General for Regional Policy, the European Commission and the URBACT Secretariat.
